# Q Why have home child care fees been frozen?

A The fees have been frozen as a legislated requirement for all agencies who have opted into the Canada Wide Early Learning and Child Care Plan (CWELCC).

# Q Who does the fee reduction apply to?

A The fee reduction applies to all families in your care. This includes the eligible private children you are caring for?

# Q When will caregivers receive a pay increase?

A We are unsure at this time, but will continue to administer fundings and grants as they are distributed to the agency. You have received some one-time funding / grants over the past couple of years as the municipalities receive funding from the province. This allows Family Day to distribute funding and grants to you. It is important to note that funding / grants are never guaranteed and may have specific guidelines and / or processes as to how they are to be distributed by licensed home child care agencies. We continue to advocate at all levels recognizing the importance of the work that you do, and the value of licensed home child care in the early learning sector.
